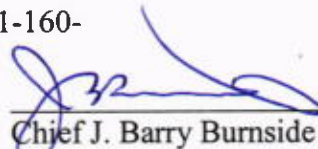

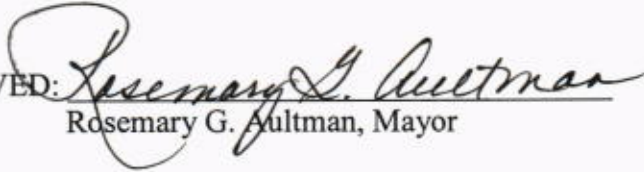
ACCEPTANCE OF A \$568.45 DONATION FROM FRED'S TO PURCHASE FIRE PREVENTION MATERIALS
