City of Clinton, Mississippi

WHEREAS, Keep Clinton, MS Beautiful will become a certified Keep America Beautiful System on April 17, 2007. The Keep Clinton Beautiful Organization is the 26th community in Mississippi to attain this important recognition by the Keep America Beautiful System (KABS).

WHEREAS, by participating in Keep Clinton, MS Beautiful, government, businesses, and citizens can raise awareness about the need and benefits of preventing litter and enhancing beautification efforts in our community.

WHEREAS, Keep America Beautiful System was established in 1976 using proven methods to sustain litter reductions within a community and to improve waste handling methods. The Keep America Beautiful System is a partnership of government, business and civic leaders working together to reduce littering and build civic pride.

WHEREAS, the goals of keep Clinton, MS Beautiful are (1) to reduce litter by 30% as measured in the litter index; (2) to promote litter prevention and awareness; (3) to create a sense of community ownership; (4) to establish a partnership with local schools and organizations, and (5) to develop and maintain an educational/awareness plan as part of their curriculum.
