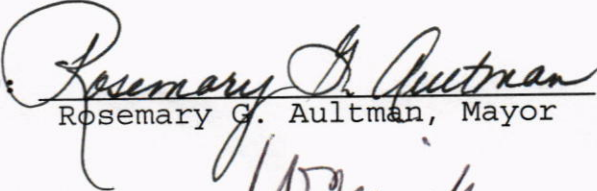
Aldermen Phil Fisher and Herb Touchton were absent.

MOTION was made by Alderman Brabham and SECONDED by Alderman Lott to adjourn. MOTION CARRIED UNANIMOUSLY

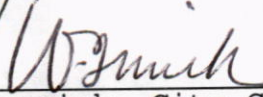
