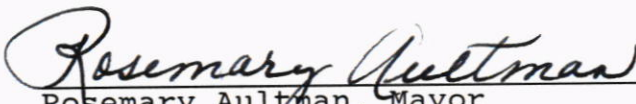

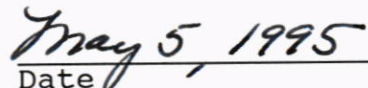
NOTICE OF SPECIAL MEETING OF
